- Status of NAC rules
 - Proposals
 - Judges right to give seminars 1 month before judging NACs (Sweden)
 - This will be deleted again
 - Standard course time should be decided the same way as FCI will use (winning time *1,15) (Sweden)
 - Already there from 2018. According FCI, put in from now I NAC rules

- Team class will consist of TWO teams from each country. Every team consists of 4, the best 3 will be counted. This will make the competition more interesting and more dogs may compete. (Sweden)

This was diskusted, the price will increase and the idea of championship will go away. This is a political discussion.

The idea of going back to 1 team and 4 dogs sounds better, but the “fun” part of the “power-run” will go.

The cost for NAC will increase dramatic, there is already now complain of the price for NAC.

We will see into new ideas. For now not accepted.

- The national judge should create and judge one of the individual runs and one team run. This will make the competition more interesting for the national judge and the international judge doesn't get to long days. (Sweden)
- Measuring of Swedish dogs into FCI classes (Norway)
 - XS and XL will be in S or L, as the extra size in just and add on to present classes.
